PRIVACY STATEMENT

Sevenoaks U3A requires you as members to provide your personal information so that you can be kept informed about events and activities that are offered as part of your membership. In collecting your information Sevenoaks U3A will store it securely to:

1. Maintain a membership database.
2. Provide names and addresses to the Third Age Trust for the distribution of the Third Age Matters magazine (5 per year).
3. Provide names and addresses to external partners for the distribution of publications and Membership Cards. Our agreement with external partners requires them to delete the mailing list after distribution.
4. Provide email addresses to our internal Distribution Team for the electronic distribution of the eNewsletter & other information of interest to members, including documents required by our constitution.
5. Provide names and addresses to HMRC as required in relation to our annual Gift Aid application (only applicable to those members who have consented to Gift Aid their subscription).

GIFT AID

If you pay Income Tax, please Gift Aid your subscription to U3A Sevenoaks. All you have to do is fill in a form. U3A can then recover 25p for every £1 you pay for your subscription from HM Revenue & Customs.

Signatories must pay Income Tax at least equal to the tax that U3A can reclaim (£3.25 on a £13 subscription). You may cancel your Gift Aid declaration at any time and you may complete a declaration for more than one charity. Your declaration remains valid until cancelled. There is no need to complete a declaration every year. Please remember that your declaration must be cancelled if you no longer pay Income Tax.

Please note that the declaration can be completed if only one member of a joint membership is a taxpayer. Gift Aid can still be recovered on the entire subscription.
